A Solution

Individuals and families can call **211** to get connected to critical resources and services 24 hours a day, 365 days a year. Certified call specialists provide confidential and caring support, helping families explore options, connecting them to resources and making referrals to Care Coordinators for individual support and follow-up when additional assistance is needed.

Homeowner "Back on the Right Track" After United Way's Help

Mable Allen needed help paying her mortgage and utility bills. It was right before Thanksgiving 2021, and the widowed 67-year-old food service worker sought assistance from a Hamilton County program that draws on federal relief funds.

She was approved for help with utility bills but was denied mortgage assistance because her mortgage company failed to submit a required vendor form. Mable repeatedly requested that the company complete the form, without success.

When the mortgage company began foreclosure proceedings, Mable worried she would lose the Springfield Township home she and her late husband bought in 2017. "I was very upset," she said, "because I felt like I had been doing everything I could to get help." Then she called the United Way 211 Helpline.

A 211 Care Coordination team member contacted Mable's mortgage company and explained the mortgage assistance program. Emails were exchanged over a period of months. In December 2022, the Care Coordinator informed Mable that the mortgage company had submitted the required form.

"I was so happy and so grateful," Mable said. She was even more elated after receiving word that her mortgage payments were current, allowing her, in her words, "to get back on the right track."

BLACK-LED SOCIAL CHANGE

UNITED IS THE WAY TO CHAMPION CHANGE

The Issue

Poverty disproportionately impacts Black families in our region, and many systems that families depend on are inequitable. We believe those closest to any challenge (in this case, Black changemakers) are closest to the solution, yet often furthest from the resources to bring those solutions to life.

A Solution

People closest to community challenges often have the best perspective on how to solve them. Black-led Social Change focuses on bringing people with diverse ideas together to look for ways to build a stronger community by leveraging the unique strengths and opportunities in our region..

BLACK EMPOWERMENT WORKS

A network of Black leaders, through our Champions of Change program, set an agenda for what Black social change should be in Cincinnati. The first cohort of Champions won National Philanthropy Day's first **INNOVATORS OF CHANGE** award, given in 2021 by the Association of Fundraising Professionals Greater Cincinnati Chapter.

Now in the third round of funding, Black Empowerment Works continues to promote Black self-determination, social mobility and economic prosperity by resourcing and funding grassroots-generated, Black-led work.

90% OF FUNDED BLACK EMPOWERMENT WORKS ORGANIZATIONS

were able to build capacity – strengthen infrastructure, management, staff and growth – during the first grant year. This puts each in a better position to achieve their mission, instead of focusing on survival.

SUPPORTED BY 38 COMMUNITY reviewers, Black Empowerment Works awarded \$1 million in grants to 45 Black-led initiatives from 2021-2022.

Entrepreneur Empowers People to Achieve Optimal Health

Deasa Dorsey, a registered nurse, often hears patients with Type 2 diabetes say, I can't. She reminds them: You can still lead a healthy, fulfilling life. She explains how in a colorful, easy-to-understand paperback called the "iCan Manual: My Simple Manual For Living With Diabetes," which she completed in 2018. She then launched her business, iCan Health Inc., which empowers people to reach an optimal state of health.

When community events designed to increase exposure for the manual and business were canceled in 2020 due to the COVID-19 pandemic, iCan Health got a much-needed boost. Deasa received a United Way of Greater Cincinnati Black Empowerment Works grant. Since then, iCan Health has received two more rounds of Black Empowerment Works funding. Deasa has expanded the reach of her educational presentations to community events, health fairs, churches – even barbershops, a favorite hangout for many Black men, who are at the highest risk for diabetes.

The grants also opened doors to other partnerships. This year, CareSource, a nonprofit health plan, bought more than 6,000 iCan manuals to distribute in Cincinnati and Dayton. "Ever since the first Black Empowerment Works grant, we've been taking off," Deasa said. "As I go into communities, I'm watching lives be changed. I feel like I'm making a difference."

FREE TAX PREP

UNITED IS THE WAY TO IMPROVE FINANCIAL STABILITY

The Issue

Many working low-income families are eligible for refunds and other benefits, such as **Earned Income Tax Credit (EITC)** and **Child Tax Credit**, but they might lose them if they fail to file their taxes. Unfortunately, some families are confused by the process or unable to pay for professional tax preparation, which costs about \$270 in fees per year.

A Solution

Free Tax Prep can save money for families, especially those with children, plus find tax benefits such as the EITC, which can increase refunds up to \$5,000.

Taxpayers Praise Free Tax Prep Service

Dayle Newman, who works in manufacturing, looks for ways to protect his hard-earned money. He has avoided tax preparation fees by taking advantage of United Way's Free Tax Prep service the last several years. Its IRS-certified volunteers also ensure he gets the tax credits he deserves. Getting a refund is important, Dayle said. "I rely on it every year. I try to put it away for a rainy day."

Schone Walker, a private duty caregiver who has relied on Free Tax Prep for about four years, takes comfort in knowing

the volunteers are knowledgeable about the latest tax laws so she doesn't have to be. "It takes the worry off your shoulders," she said. "I trust the volunteers 100%."

Ivonne Dominguez greatly appreciated the help she received. "I can barely pay the taxes. How am I going to pay a tax preparer?" she said. Free Tax Prep volunteers helped her. "They got me as much refund as they could. It was important to receive the money. At that time, I had no money. That helped me buy things I needed – clothes and my car payment. It was a relief."

Constructing A Successful Career

For **Mecca Lee**, landing a full-time construction job in November 2022 was the culmination of much hard work, including the completion of two intensive training programs. Mecca, a mother of two, received more good news when she qualified for a program that helped her get a car to go to and from work. She needed car insurance, though, and she couldn't pay the premiums until she earned a few paychecks.

She then connected with United Way's Project Lift, which removes barriers so families can attain financial stability.

By providing critical, short-term assistance, the program enables families to achieve long-term success. "The fact that Project Lift was able to pay my insurance for six months was a blessing – a complete, God-given blessing," Mecca said. She is now financially stable and pays the bills herself.

"I get up every morning ready to go to work," said Mecca, a journeyman laborer. She received a raise in the spring and plans to enter a carpentry apprenticeship program. "I've always liked working with my hands." Now she is building her own path to a better future with help from Project Lift.
